NEW YORK CITY POLICE DEPARTMENT DEPUTY COMMISSIONER

Maureen E. Casey has been Deputy Commissioner of Policy and Planning since August 1999. Ms. Casey directs the 105 members of the Office of Management Analysis and Planning, the Police Commissioner's research, planning, and policy development staff. She serves as policy advisor to the Police Commissioner on a variety of operational, managerial, and administrative matters affecting the Department. Ms. Casey is responsible for crime statistics, grants, audits, and policy analysis covering the full range of police operational and management issues. She serves as a special advisor to the Commissioner and the Department regarding DNA initiatives and coordinates several of these, including the outsourcing of 16,000 rape kits for DNA analysis and the collection of DNA samples used to identify victims from the World Trade Center attack and American Airlines Flight 587 plane crash.

Ms. Casey lectures on various topics to law enforcement and community groups. Her past positions include: Counsel to the First Deputy Commissioner, from April 1997 to July 1999; General Counsel to the New York State Division of Criminal Justice Services, from December 1994 to February 1997; staff attorney, from September 1991 to December 1993; Counsel to the Capitol office to the Governor's Director of Criminal Justice, from January 1994 to November 1994; and Assistant Counsel to the New York State Division of Probation and Correctional Alternatives, from October 1988 to September 1991. Ms. Casey has a Juris Doctorate from the State University of New York at Buffalo School of Law and a Bachelor of Science, Magna Cum Laude, in Criminal Justice from the State University of New York at Brockport.

At our luncheon, Ms. Casey will discuss the New York City Police Department's numerous DNA initiatives and our experiences in using this technology in the World Trade Center attack and the crash of American Airlines Flight 587.
