BETH GILINSKY

The Jewish Action Alliance



Beth Gilinski is the founder of the Jewish Action Alliance, the nation's leading grassroots Jewish civil and human rights program. It has led in the struggle against campus bigotry, Nation of Islam, Holocaust denial, skin heads and neo-Nazis, hate-mongering in media outlets and anti-Semitism in major corporations, and was the vanguard in the fight for justice for Crown Heights. The Alliance also has organized pro-Israel

rallies attended by thousands

Ms. Gilinsky, a graduate of Harvard and of Columbia University's School of International and Public Affairs, is a public information, communications and political strategist. She considers her specialty "guerilla P.R." – getting a difficult story out to a hostile media. She has been one of America's most outspoken and effective pro-Israel activists, educating the public about Jewish rights of settlement and sovereignty throughout the land of Israel.

As an activist on issues related to the Jewish people and the Middle East, Ms. Gilinsky serves on the Advisory Boards of a number of organizations, including Interfaith Action for Christian Human Rights, U.S Committee for a Free Lebanon, Interfaith Coalition for a Free Middle East, Human Rights Forum, Women for Israel, the New York City Jewish Cultural Affairs Committee, and American Academics for Israel's Future. In addition, she is known for her bold initiatives in successful coalition-building with non-Jewish groups.

Ms. Gilinsky, named one of the top Jewish leaders in America by *Forward*, is the recipient of many other honors, among them the prestigious Defender of Jerusalem Medal for the Defense of Jewish Rights.

REPORTER OF THE WEEK

Tuesday, August 6, 2002

President Silvio Amori opened the meeting promptly at 12.30p.m, followed by the singing of "The Star Spangled Banner" led by Scarlet Pildes. Giorgio Balestrieri, who shared the recent passing of Joe Sullivan, offered the invocation. Joe was a Past President, trustee and a dear friend of many NY Rotarians and he will be deeply missed. A moment of silence was observed in memory.

Rotarian, Jim Thompson introduced representatives of Project Hospitality for a special presentation. Project Hospitality is a Staten Island organization, which offers a wide range of social services. It was particularly overwhelmed on 9/11 and the months which followed. They were among the first organizations, which provided relief and aid to hundreds of displaced workers, evacuated from lower Manhattan. Subsequent aid has included meal service, psychological counseling, food pantry, holiday baskets and interfaith prayer services. For exceptional service to our community, Rev. Terry Troia, Executive Director (and Staten Island Rotarian) was presented a check for \$100,000 from our 9/11 Disaster Relief Fund in support of their efforts.

Bill Currie shared information about the "Gift of Life Regatta" taking place on with the club.

President Silvio introduced our guest speaker, Michael Cardozo, Esq., Corporation Counsel for the City of New York.

Mr. Cardozo shared a variety of real life cases typified by the "Tort Tax" which impacts all New Yorkers. Examples were offered of the ludicrous awards and claims paid by the City of New York, which amounted to \$575 million in 2001; a rise from \$21 million in 1978. Designed to deal with matters of negligence, the law as currently written allows for gross abuse. Mr. Cardozo referred to "pain and suffering" as an elusive concept, but one which should have a "cap" on the awards by the court and juries.
